

## **Jewel-Osco® Stock Your Bullpen 2025 Official Rules**

**NO PURCHASE NECESSARY** TO ENTER OR TO WIN THE STOCK YOUR BULLPEN SWEEPSTAKES (THE "SWEEPSTAKES"). A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Purchases made online or via other non-in person transactions, including but not limited to third-party delivery services will not qualify for a Game Code. Game Codes will only be awarded during the transaction in which they were earned. Customers are limited to one Game Code eligible transaction per three-hour period.
