

**Jewel Osco® Stock Your Bullpen
2022 Official Rules**

NO PURCHASE NECESSARY TO ENTER OR TO WIN THE STOCK YOUR BULLPEN SWEEPSTAKES (THE "SWEEPSTAKES"). A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

Purchases made online will not qualify for a Game Code. Game Codes will only be awarded during the transaction in which they were earned.
